

THE FANTASTIC SAMS FANTASTIC PLASTIC GIVEAWAY

1. HOW TO ENTER

- a. The Fantastic Plastic contest will begin on the Months of April, May, June, August, November and December.
- b. To participate in the contest, you may enter via the following method(s): **ON LINE ENTRY ON B94.COM**. Enter your first name and last name, complete address, city, state, zip code, home telephone number and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.
- c. 2. ELIGIBILITY RESTRICTIONS

- a. The contest is open to all persons who are [**“18”**] years of age or older and who reside in [LIMITED TO THE B94 LISTENING AUDIENCE OF THE PITTSBURGH METRO AREA]. Employees of [WBZW] (the “Station”), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Pittsburgh metropolitan area and the members of their immediate families [**AND/OR HOUSEHOLDS**] are ineligible to participate or win.
